1. 3. Amount of Empanelment Bid Security @Rs 20,000/- for each item subject to minimum Rs.2,00,000/- (Rs. Two lacs only) and maximum Rs.5,00,000/- (Rs. Five lacs only) which was deposited at the time of submission of bids shall remain with the RMSCL (**empanelment bid security should be calculated on the basis of total no. of item empanelled with RMSCL**) till the validity of empanelment / contract period which ever is later.
4. The Successful Bidders whose financial bid has been approved shall be required to submit performance Security Deposit @ 2.5% of the Contract value. The performance security shall have an upper limit of Rs 25 Lac as specified in the bid conditions.
