1. Purchase order shall be issued as per requirement. The supplier shall supply the entire ordered quantity before the end of 7 days from the date of issue of purchase order at State Vaccine Store, Sethi Colony, CMHO Office, Behind Mental Hospital Jaipur-302005 (Rajasthan).
2. If any issue/complaint regarding quality is received, RMSCL shall have right set the supplied item tested from competent laboratory. If the samples drawn from supplies do not conform to statutory standards, the supplier shall be liable for relevant action under the existing laws and the entire stock in such batch shall have be taken back by the supplier within a period of 30 days from the issue of letter from ordering authority, the information of which may be communicated by e- mail. The stock shall be taken back at the expense of the supplier. Ordering authority shall have the right to destroy such NOT OF STANDARD QUALITY vaccine doses if the supplier does not take back the goods within the stipulated time. Ordering authority will arrange to destroy the NOT OF STANDARD QUALITY drugs within 90 days after the expiry of 30 days mentioned above, without further notice, and shall also collect demurrage charge calculated @ 2% per week on the value of the drugs rejected till such destruction.
3. The Supplier shall replace the stock of NOSQ goods with fresh goods upon intimation to do so by the ordering authority within the given time period.
4. On receipt of the prescribed consolidated invoice duly stamped and signed by authorized signatory and analytical laboratory report regarding quality, the payment would be made as soon as possible.
5. All relevant provision of Rajasthan Transparency in public procurement Act 2012 and 2013 shall be applicable.
