**CLARIFICATION/CORRIGENDUM/ADDENDUM**

In reference to subject cited above NIB-605, various representation received from the firms and issues raised by the bidder are examined by the competent authorities and technical committee. The following clarification/corrigendum/addendum is issued for inclusion in bid document of items as below:-

**Revised Technical Specifications of Baby Receiving Kit-**

1. Baby Receiving Kit (Blue & Pink Color) shall contains following items:-

- Jabla made of 100% cotton flannel cloth 125 GSM (+ - 5) with front open should have vulcrown in place of buttons.
- Nappy made of 100% cotton flannel cloth 125 GSM (+ - 5) with both side string attached (7 inch both side + - 1 inch)
- Under Sheet made of 100% cotton flannel cloth 125 GSM (+ - 5) with one side cloth and other side polythene sheet (polythene sheet made of food grade plastic with 50 micron + - 2 micron) overlapped from all side.
- Blanet made of 100% cotton flannel cloth 125 GSM (+ - 5) overlapped from all side.
- Cap made of 100% cotton flannel cloth 125 GSM (+ - 5) with both side string attached (4 inch both side + - 0.5 inch)
- Socks made of 100% cotton flannel cloth 125 GSM (+ - 5)
- Document for the manufacturer – Manufacturer should have ISO 9001:2015 Certificate. This document shall be submitted along with technical bid.
- Quality of Baby Receiving- Test Report from NABL Accredited Laboratory shall be submitted along technical bid to ensure the quality of Baby Receiving Kit.
- Indira Priyadarshini Baby Kit Logo (Annexure-A)–Indira Priyadarshini Baby kit, colored sticker Size: 2inch x 4inch shall be affixed on front of packing on Pink color Baby Receiving Kit. The draft of Indira Priyadarshini Baby kit sticker is attached in technical bid
- Two Samples of each kit (Blue & Pink Kit) has to be submitted along with technical bid.
- The Baby Receiving Kit shall be supplied with packing of low density polythene (LDPE) with linear low-density polyethylene (LLDPE) octane based with 55 micron.
- A small sticker Size 2.5 inch x 1 inch shall be affixed on each kit with Name:- Baby Receiving Kit (Pink) or Baby Receiving Kit (Blue) during supply.
- On the back of both packing (Blue/Pink kit), The batch/Lot no. , details of items contained in kit and Supplier's Name shall be printed by the firm during supply.
