### CLARIFICATION/CORRIGENDUM/ADDENDUM

**Sub:- Amended technical specifications of the rate contract for D-Type Big size Medical Oxygen Cylinder (Manganese Steel) for under NIB No. F-8( ) RMSC/EPM/M-3/21-22/NIB-601/760 dated 03.06.2021.**

In Reference to subject cited above and NIB-601, the various representations received from the firms and issues raised by the Bidders are examined by the competent Authorities and technical committee. The following Clarification/Corrigendum/Addendum is issued:-

#### Revised Technical Specification of D-Type Big size Medical Oxygen Cylinder ISI /ISO Mark (220 CU.FT.)

1. D-type high pressure seamless cylinder for medical oxygen gas, cylinder is ISI marked conforming to IS: 7285 Part 2 certified by the Bureau of Indian Standards (BIS)/IS 9809 Part-1, 2, 3 and approved by the Chief Controller of Explosive (CCOE), Government of India.
2. Cylinder made from manganese steel.
3. 46.7ltr. water capacity (220 CU.FT.).
4. Fitted with bull nose type valve as per IS: 3224, and neck cap.
5. Valve made of brass and chrome plated.
6. Working pressure 150 kgf/cm<sup>2</sup> at 15 °C.
7. Hydraulic test pressure 250 kgf/cm<sup>2</sup>.
8. Colour code of the cylinder should be as per IS: 3933-1966 with updating till date.
9. Certificate: Manufacturing certificate, ISI/ISO certificate & Department of Explosion, Government of India to be provided for cylinders.
10. Filled /Empty with medical oxygen gas.
11. Matching key cum spanner to release oxygen for each cylinder separately.
12. Minimum two years guarantee for cylinder.
13. In case, if bidder is an importer, it should have PESO approval to import the oxygen cylinder along with third party inspection from recognized agency by CCEO and relevant document should be submitted in technical bid.

**Note:-** Please note that all above amendments/corrigendum in technical specifications/bid conditions is the integral part of (Section-V, Schedule of Supply, and Point no. 3) and the bid document. This corrigendum/ addendum should be signed and annexed with bid document. All other terms & conditions remains the same.
