1. **SECTION III, Point no. 1-Qualification Criteria, Clause no. 2 -Contractual experience, Point no. 1 and SECTION VI A: General Conditions of Rate Contract (GCC), Clause no.-2.1(i) should be read as:-**

"The bidder should be Manufacturer/Direct Importer/Consortium for core item Mannequins specified in Bid. E-Commerce or other foreign company mediation with bidder would not be allowed in this bid."

Instead of "The bidder should be Manufacturer/ Direct Importer (import from single foreign principal manufacturer) for 50% or more of the core Item Mannequins specified in Bid and for remaining 50% Mannequins, the bidder should enter into consortium with other manufacturer/ direct importer. E-Commerce or other foreign company mediation with bidder would not be allowed in this bid."
