Note:-

1. The empanelment shall remain valid upto 30.11.2024 as per submitted documents in concerned bid (NIB 15/2022) provided that the firms empaneled possess all essential qualifications as prescribed in the technical bid. In case of expiry of any required document, change of status, financial figures etc concerned firm has to immediately inform and replace with fresh valid document to remain on panel.
2. Financial proposals for any particular item would be called from empanelled firms on e-proc site of GoR i.e. <https://eproc.rajasthan.gov.in/> as and when required. All other terms & conditions (including all corrigendums) shall be as per concerned NIB / NIPQ issued by RMSCL.
3. Those bidders who have already deposited bid security and such bid security is still lying with RMSCL then the same can be considered and need not deposit again for same items. In case of any additional items or not deposited adequate bid security as per tender requirement, bidders should submit bid security i.e. Rs 20,000/- each item subject to over all minimum Rs 2.00 lacs and maximum Rs 5.00 lacs in the form of DD/BC/Challan (format attached) in favour of MD RMSCL payable at Jaipur failing to which they would not remain in panel and would not be eligible to submit financial bids.
4. Those bidders who have already submitted empanel fees Rs. 5000+18% GST in previous tenders invited on or after 09.12.2022 (NIPQ-01/2022 onwards) need not submit empanelment fee again, however bidder has to submit a request along with details of empanelment fee already deposited in RMSCL.
