The parameters to arrive at the matched rate are as follows:-

S.No.	Particulars	Rate to be offered for rate match
1	L-1 rate approved firm is out of Rajasthan, and rate approved is basic + CST. Then rate match offer to the firm of Rajasthan or the firm which are not liable to pay CST to be given at the basic rate or basic rate + CST because VAT for firm of Rajasthan is exempted.	Local Valid tendering units of the state of Rajasthan or the firm which are not liable to pay CST and offered to parallel the contract, such unit will be entitled only approved naked (basic) rate excluding CST / concessional CST.
2	L-1 rate approved firm is of Rajasthan, or the firm is not liable to pay CST and rate approved is basic + VAT / CST exempted. Then rate match offer to the firm which belongs to other state to be given at basic rate + CST or basic rate including CST.	In case a unit outside Rajasthan and is liable to pay CST, offered to parallel the contract, such unit will be entitled only approved naked (basic) rate inclusive of CST . In other words CST shall be borne by the supplier.
3	Rate of CST for the firm approved as L-1 is 2% whereas the rate of CST for L-2, L-3..... firms is 1% or 1.5% then the offer of rate match to be given at basic rate + CST @ 2% or 1% or 1.5%	In case a unit is availing the facility of concessional CST and is offered to parallel the contract, such unit will be entitled only for naked (basic) rate plus applicable concessional CST.
4	Rate of CST for the firm approved as L-1 is concessional i.e. 1% or 1.5%, than the offer of rate match to be given at basic rate + concessional CST or 2% CST.	In case a unit is not availing the facility of concessional CST is offered to parallel the contract, such unit will be entitled for a rate+2% CST which equal to approved L-1 rate inclusive CST.

Note:-

1. MSME unit of the state of Rajasthan may match the L-1 rate. They will get order as per bid condition no 3.
2. As per bid condition no 3 -The orders may split between L-1 and rate matched firms.
