- 2. Financial proposals for any particular item would be called from empanelled firms on eproc site of GoR i.e. https://eproc.rajasthan.gov.in/ as and when required. Other terms & conditions shall remain the same as per tender documents and corrigendum as issued time to time.
- 3. Amount of Empanelment Bid Security @Rs 20,000/- for each item subject to minimum Rs.2,00,000/- (Rs. Two lacs only) and maximum Rs.5,00,000/- (Rs. Five lacs only) which was deposited at the time of submission of bids shall remain with the RMSCL (empanelment bid security should be calculated on the basis of total no. of item empanelled with RMSCL) till the validity of empanelment / contract period which ever is later.
- 4. The Successful Bidders whose financial bid has been approved shall be required to submit performance Security Deposit @ 5% of the Contract value. The performance security shall have an upper limit of Rs 25 Lac as specified in the bid conditions.
- 5. All empanelled firms/ suppliers are directed to submit firms name and DSC ID to RMSCL on mail edprmsc@rajasthan.gov.in so that financial bid invitation can be forwarded to concerned firms. Non-submission of aforesaid information would lead to non participation of such firms in financial bid for which they themselves would be responsible.
