- 1. - 3. Those bidders who have already deposited bid security and such bid security is still lying with RMSCL then the same can be considered and need not deposit again for same items. In case of any additional items or not deposited adequate bid security as per tender requirement, bidders should submit bid security i.e. Rs 20,000/- each item subject to over all minimum Rs 2.00 lacs and maximum Rs 5.00 lacs in the form of DD/BC/Challan (format attached) in favour of MD RMSCL payable at Jaipur failing to which they would not remain in panel and would not be eligible to submit financial bids.

4. Those bidders who have already submitted empanel fees Rs. 5000+18% GST in previous tenders invited on or after 09.12.2022 (NIPQ-01/2022 onwards) need not submit empanelment fee again, however bidder has to submit a request along with details of empanelment fee already deposited in RMSC.
