- 3. Amount of Empanelment Bid Security @Rs 20,000/- for each item subject to minimum Rs.2,00,000/- (Rs. Two lacs only) and maximum Rs.5,00,000/- (Rs. Five lacs only) which was deposited at the time of submission of bids shall remain with the RMSCL (empanelment bid

4. The Successful Bidders whose financial bid has been approved shall be required to submit performance Security Deposit @ 2.5% of the Contract value. The performance security shall have an upper limit of Rs 25 Lac as specified in the bid conditions.
