11.	Technical Specification of the Dental Chair:- A. Electrically operated microprocessor based multi programmable dental chair with both left and right handed dentistry option. Dental chair should have certification from European CE/USFDA/BIS. B. The chair should have minimum 2 erasable programs with microprocessor controlled, where doctor can set his own programs. The programs switch should be fitted to the instrument tray. C. Perfectly body counteracted chair. D. The right side arm of the chair has lateral rotation for easy access of the patient. E. The chair base should have rubberized cover. F. The seat and head rest should be laminated.	



1. Chair Mount Unit fitted with:-

- Water connection for spittoon and tumbler. Spittoon should be made up of single piece high quality porcelain and it should be removable for cleaning to maintain better hygiene.
- Stainless steel instrument tray with UV light fix, for keeping instruments.
- Water adjustment for hand pieces should be in coupling.
- LED X-Ray viewer (Emitting white light).
- High & low vacuum motorized suction with flow control valve; auto drain and flush system having flow rate of 300litre per minute $\pm 10\%$ tolerance.

2. Under Arm Delivery under Arm Delivery Unit:-

- 3 Way syringe for Air, Water & Spray
 - 2 No. one for doctor and one for assistant.

3. Dental Operators Stool:-

- Should be latest surgical stool having rising and lowering by pneumatic piston with powder coated legs (stool frame made of strong rust proof materials). Back rest should move forward and backward along with the body by pneumatic piston and it should give support all the time.
- The seat should have a piston to move with the body when a Surgeon leans forward.
- Moving on five wheels with Euro moulded seat, back rest, pneumatic system for upward and downward movements.

4. Suction Apparatus (additional apart from main unit):-

Should be motorized suction, made up of steel epoxy coated fitted with oil immersed motorized vacuum pump with two graduated suction jars each of 1.5 Litre capacity with synthetic/silicon rubber lids, long pressure tubing, vacuum control, automatic overflow cut off device, should be mounted on rubber wheels.
