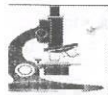

 - c) Should be rechargeable battery operated compact (less than 3 Kg) hand held type, not bench top type.
 - d) Sealing time should not be >2 sec
 - e) Electrodes should be well protected by a cover to prevent blood splutter. (Optional).
 - f) Sealing should be automatic on sensing tube/Pressing Handle/Pressing button.
 - g) Should have indicator lamp for sealing process
 - h) No warm up time should be required
 - i) Should have tear-seal feature to make segments that can be easily separated by hand
 - j) No. of seals per charge should be minimum 700 to 1000 continuous seals from a fully charged battery. Charger should be compatible with Input voltage: 240V 50 Hz Single phase AC
 - k) The NIMH/LiPo Battery used fully Charge with 3 hour back up showing indicator.
4. Transport Box and carry bag for using the device in camp and carrying in camp.
5. Guarantee: Three years on equipment from the date of installation.
