SPECIFICATIONS OF SINGLE CHANNEL MICROPIPETTES-VARIABLE VOLUME

- The single channel pipette should be in volume range of 0.5-10 µl, 20-200 and 100-1000 µl respectively supplied with stand and respective tip boxes.
- The pipette should be light weight & ergonomically designed with least RSI ( Repetitive Strain injury).
- The pipette should have a large and easy read digital display.
- The pipette should have volume locking button to prevent accidental volume change.
- The pipette should be highly chemical & UV resistant.
- The pipette should be fully autoclavable.
- The pipette should have separate soft touch tip ejector.
- The pipette should have volume range color-coding system.
- The pipette should have cone filters to prevent contamination.
- It should be capable of in lab calibration and easy maintenance easy to open with no special tool required.
- Set of minimum sterilized 100 pipette tips with their respective boxes should be supplied with each pipette.
- The pipette should be CE certified & IVD approved.
- The pipette should be calibrated once a year with NABL certificate during 3 year warranty period and should have in house calibration support to be provided.
- Thermal insulation of internal components ensures that warmth of hand does not affect the pipetting results.
- For each range, it is preferable to mention the increment required (eg. 1 µl, 0.01 µl etc.)
- Cost of Vertical pipette stand for 4 pipette must be mentioned in Online BOQ.

- The agreement signed between RMSCL and the firm forms integral part of the rate contract.
