### CLARIFICATION/CORRIGENDUM/ADDENDUM

In reference to subject cited above and NIB-535, the various representations received from the firms and issues raised by the bidders are examined by the competent authorities and technical committee. The following Corrigendum/Addendum is issued for inclusion in bid document as below:-

#### Foam Mattress Size 72"x36"x4"

S. No.	Technical Specifications
1.	Foam Mattress size should have 72"x36"x4" with good quality washable rexine cover with zip of lasting quality.
2.	Foam Mattress should have IS 1741:1960/IS 7933:1975 certified & amended up to date. <b>Test report from NABL accredited Lab must be submitted in Technical bid.</b>
3.	Foam mattress should be made of minimum 40 density from latex foam rubber/ PU foam of minimum 100 mm thickness
4.	Mattress should not break by pinching or pressure & should not get compressed in less than 2 years.
5.	Rexine shall have feature of antibacterial, anti dust mites, antifungal, anti allergic and fire retardant and should follow/compliance IATF 16949:2016, relevant govt. approved test report should submit at time of technical bid.
6.	Rexine thickness should have minimum 0.70mm to 1mm and weight of the rexine should have minimum 600-650gm/sqm
7.	Guarantee on the item shall be two year after delivery against any manufacturing defects

#### Foam Mattress for Fowler Bed

1.	Four sections foam mattress of size: 78"x33"x4"
2.	Foam Mattress should have IS 1741:1960/IS 7933:1975 certified & amended up to date. <b>Test report from NABL accredited Lab must be submitted in Technical bid.</b>
3.	Foam mattress should be made of minimum 40 density from latex foam rubber/ PU foam of minimum 100 mm thickness
4.	It should be good quality washable Rexin cover with zip of lasting quality.
5.	Rexine shall have feature of antibacterial, anti dust mites, antifungal, anti allergic and fire retardant and should follow/Compliance IATF 16949:2016, relevant govt. approved test report should submit at time of technical bid.
6.	Rexine thickness should have minimum 0.70mm to 1mm and weight of the rexine should have minimum 600-650gm/sqm
7.	Guarantee of two years against any manufacturing defect from the date of delivery.
