The kit should consist of a booklet containing a set of six shades of red and 1x200 strips in a dispenser box that must contain 100 strips on each side of the box having 2 openings dispensing sides containing 50x2(100) strips on each side totaling to 200 strips. A sample must be deposited along the tender3. The shades represent a range of Hemoglobin value from 4 to 14 g/dl. By matching the colour of a drop of blood (fresh capillary blood) on a test-strip with one of the shades of red, you can see if the blood is anaemic and, if so, the severity of anaemia in clinical terms.4. Ideally suited for tested in the clinic.5. Highly accurate and precise results comparable with the best laboratory methods.6. Used by various international agencies for field survey and testing.7. It should be CE/ISO 9001 certified. It should be WHO recommended and validation document from Confederation of American Pathologist Accredited (CAP) or National Accreditation Board for Testing and Calibration Laboratories (NABL) must be attached with the tender and the validation must be submitted of the current batch to be supplied by the supplier. The certifying laboratory should have facility/ scope of testing/ examining the said parameters from NABL.8. For comparison of rates the prices per unit of HSB with a pack of 200 special absorbent test-strips and prices per pack of 200 absorbent test-strips shall be added.
