- 1. Base Vehicle-
 - (i) Physical Characteristics
 - (a) Seating Capacity: Minimum 06 personnel including driver and co-driver
 - (b) Braking system: Disc brakes/ Drum Breaks
 - (c) Transmission: Manual
 - (d) Drive System: 4x2
 - (e) Suspension: Independent/ Leaf spring with shock Front and Rear
 - (f) Wheeled/Tracked: Wheeled
 - (g) Steering: Electronic/Hydraulic Assisted Power Steering
 - (h) Cooling: AC system engine driven and 2 ton split air conditioner Alternative Current driven
 - (ii) Base Vehicle Operational Characteristics:
 - (a) Ground Clearance: Not less than 180 mm
 - (b) Minimum payload: Not less than 1500 kg
 - (c) Engine power: not less than 100 HP
 - (d) Maximum speed: Not less than 80 kmph
 - (e) Operating range: Not less than 350 km
 - (f) Operating temperature: 0-50°C.
 - (g) Fuel type: Diesel
 - (h) Fuel tank capacity: Not less than 70 litres
 - (i) Safety arrangements: Seat belts with three point harness for all two front facing seats with quick release latch.
 - (i) Accessories: Accessories as under should be provided with vehicle.
 - a. Spare tyre: one qty., along with mounts & tyre assembly.
 - b. Jack: One qty., along with on vehicle mounting kit.
 - (k) Length: Not less than 6500 mm
 - (1) Width: Not less than 1800 mm
 - (m) Height Not less than 1980 mm
 - (n) Wheel Base not less than 3600mm
 - (iii) Other requirements:-
 - (a) The base vehicle should be of CMVR approved 'M' Category **cowl** chassis of an Indian Original Equipment Manufacturer (OEM).
 - (b) The base vehicle chassis should be able to accommodate the blood donation van compartment on the original OEM chassis length without any extension of the chassis frame.
 - (c) The assembly, sub-assembly and equipment should be integrated in such a way so as to enable the vehicle function in a reliable way and in a sustained fashion with durability and ensuring safety and comfort to occupants.
 - (d) The design of the vehicle and the specified requirements shall permit accessibility for servicing / replacement and adjustment of components / parts and accessories, with minimum disturbance to other components and systems.
 - (e) The base vehicle with all accessories should be brand new standard commercial products, tested and certified to meet the necessary application requirement in terms of load. The bidder should enclose all necessary brochures, certifications and proofs in this regard along with the technical bid.
 - (f) The base vehicle should fully comply with all requirements of CMVR (as per the latest amended applicable on the date of submission of bid). A copy of the certificate to this effect should be enclosed with the technical bid.
 - (g) The base vehicle should be able to accommodate the Mobile Blood Donation Van

without violating any of the statutory requirements of the CMVR including the rear overhang and side extensions beyond the width of the vehicle if any as well as the safety requirements like rear view mirror positions with the complete width of the MBDV loaded onto the chassis.

2. Body Compartment

(a) General requirements

- i. Should have an air-conditioned work space which should be able to maintain the internal vehicle temperature at 15-25°C (adjustable), CFC Free
- ii. Should have a hard roof.
- iii. Side walls should have puff insulation.
- iv. Should have seating for four people in addition to the driver & co driver.
- v. Should have inbuilt filing cabinets and cupboards for storage of documents and other consumables.
- vi. Should have adequate LED lighting for reading/writing
- vii. Should have a invertor of adequate capacity to provide 100% uninterrupted power backup.
- viii. Overhead racks for storage.
- ix. Non static, chemical-resistant, non-absorbable material, anti-skid flooring (minimum 2 mm thick PVC flooring).
- x. Grab rail on rear entry door for easy access.
- xi. Rack(s) for blood transportation boxes.
- xii. Medical cabinets for storage.
- xiii. Space for adjusting additional resting bed(s) for donors.
- xiv. Roof mounted stainless steel hand support rail with 2 Nos. of strap handles.
- xv. Sanitizer dispenser.
- xvi. Fire extinguisher Minimum 02 nos.

(b) Donation compartment

- i. Donation area: minimum 2 couches.
- ii. Two additional resting beds (foldable) for donors with mattress.
- iii. Foldable table Minimum 01 no. **minimum height 2.5 feet with mattress** and Foldable Chairs Minimum 02 no.
- iv. Blood Bank Refrigerator Minimum 01 no.
- v. Blood Collection Monitor Minimum 02 no.
- vi. Portable Tube Sealer Minimum 01 no.
- vii. Tube Stripper Minimum 02 nos.
- viii. Sampling, blood storage area
- ix. Biomedical waste area
 - x. Underneath dickey for storage, electrical equipment, invertor etc.
 - xi. Storage compartments for expandable/consumable medicine stores.
 - xii. All interior and equipment should have smooth surfaces with no sharp projections. They should be made of durable, non-absorbable, corrosion-resistant, and easy-to-clean material. It must be possible to completely remove blood stains.

(c) Inter-frame Work:-

- i. Inter-framework should be made of minimum 4mm thick steel complying with ST 52 Grade rolled / folded cross member and long member channels. The interframe cross member shall be welded with long member using gusset.
- ii. The inter-frame work should be connected to the chassis frame in such a manner as to prevent any shifting and separation under extreme operating conditions.

- iii. Inter-framework should be designed to support the MBDV body rigidly and withstand tensional loads under full dynamic conditions.
- iv. The inter-frame should be designed to ensure optimum stability of the complete construction of the MBDV along with complete fitments as well as passengers inside in both static as well as dynamic load situations.
- v. MBDV body should be attached to the inter-framework in such a manner as to prevent shifting or separation of body from inter-framework under severe operating conditions (crash or accident).

(d) Floor and Roof:

- Floor should have reinforcements for receiving and fastening for the floor plate to the inner framework as well as to fix the seats for the passengers inside the Mobile Blood Donation Van.
- ii. The bolts used to fasten the floor to the inter-frame should be fully flushed with the top skin of the floor panel in full tight condition without any obtrusions of any kind.
- iii. The top layer of the floor should be made from minimum 2 mm. thick anti-static, Anti-skid PVC vinyl matting or FRP / ABS with Anti-skid coating may also be used as the final covering. Chemical-resistant, non-absorbable material, anti-skid flooring (minimum 2 mm thick PVC flooring).
- iv. The floor should withstand a distributed load of minimum 200Kg/m².
- v. The floor should have the necessary opening to access the spare wheel of the vehicles, as per the recommendation of the chassis manufacturer as applicable.
- vi. The floor should be completely free from any cuts / opening to access any parts of the OEM engine or chassis parts including access to the spare wheel. Joints if any should be properly sealed so that it will not accumulate any dust and facilitate easy cleaning.
- vii. In normal usage condition this opening / Joints should be congruently matched with the floor hygienically and aesthetically, so that there is no chance of dust and pollution through that opening to the inside environment of the MBDV.
- viii. The construction of the roof should be exactly the same as those of the body walls as specified above but with additional reinforcement for mounting air conditioning unit, ceiling lamps and other devices to be mounted to it.
- ix. All the cables and conduits in the ceiling should be completely concealed in its manufacturing and should not be visible either on the inside surface or on the outside surface of the ceiling.

(e) Entrance Door:

- i. There should be one entrance door on the LH side of the MBDV.
- ii. The doors should be minimum JK door.
- iii. The door should be designed as to afford easy release and prevent accidental opening.
- iv. The door should have minimum possible horizontal opening permitting loading and unloading of the stretcher.
- v. It should have effective compression or overlapping seals to prevent leakage of exhaust fumes, dust, water, and air.
- vi. The door hinges should be completely concealed in construction so that when the door is closed it is not possible to open the fastening hinges from any direction with any type of tool.
- vii. The door should be locked at its fully open position.
- viii. A handle should be provided in unobstructed location inside doorway.
- ix. The door should have flush pull latch lock to allow operation from inside.
- x. It should be possible to open the door from inside by simply pulling the latch even if

- the door is locked from outside with the keys.
- xi. All hardware should be certified for passenger vehicle usage.
- xii. The door should be provided with a retractable handle to open it from outside. On releasing the handle it should be flushed with the outer surface of the door.
- xiii. When the key is not engaged there must be an integrated aperture to close the key slot so that there is no ingress of any liquid or dust to the inside of the lock assembly.
- xiv. The lock must have two locking points (dual lock system for passenger vehicle use) at both the ends vertically (top and bottom) operated / actuated by the one handle.
- xv. The complete lock assembly with the integrated handle should be surface integrated in construction without any outside projecting or protruding parts on the surface on both the internal and external sides.

(f) Window

- i. The MBDV should have **suitable three windows** with sliding glasses.
- ii. The window frame should be manufactured as one single piece and without any sharp edges or corners.
- iii. All the four corners should be produced in appropriate radius without any sharp edges or corners of any kind.
- iv. The window frame should comprise of two parts joined in such a way as to cover the complete width of the panel as one single piece without any gaps allowing any ingress of materials or liquids there by creating a source of any infection.
- v. Both the windows should provide effective ventilation and outside vision for the MBDV staff.
- vi. The tinted glass should be set in an acceptable manner in a sturdy durable electrostatic black powder painted aluminium frame.
- vii. The sliding window should be equipped with a positive latch / lock that can be secured from inside of the MBDV.
- viii. The glass used in the window should be of automotive grade.
- ix. The window should be flushed with the external wall without any protrusions outside.

(g) Staircase:

- i. The side entrance door for the MBDV will have a **fixed stair case**.
- ii. The staircase should be designed in such a manner so as to prevent accumulation of dirt.
- iii. The height between each step shall be comfortable enough to walk and shall be flat during operation.
- iv. Step surfaces shall be non-slippery.
- (h) Service Area: The service area should accommodate the control systems, battery and other general as well as special utility devices, which are necessary for running the MBDV but can be segregated separately as service utilities.
- (i) Air conditioning:

Minimum 5 tonne AC, engine driven.

and

Minimum 2 tonne AC (condenser coil material-Copper), Alternative current driven with 5 star BEE star rating with suitable stabilizer (copper winding)

Air-conditioning system in the vehicle to maintain temperature of 15°C to 25°C (adjustable in 50 degree Celcius ambient temperature conditions including 6-8 persons).

(j) Wiring:

- i. All wires shall be concealed (channels to be provided in the walls) and so arrange that they can be readily inspected and renewed without affecting the finish of the vehicle.
- ii. All the wires in the roof of the vehicle should be concealed type but with defined service points for checking as well as re-wiring in case of any need.
- iii. The wires shall be PVC insulated wires confirming to BIS specification.
- iv. Wiring shall be of sufficient size to carry the required load without excessive voltage drop.
- v. The earth return system shall be used for body wiring.
- vi. Wherever PVC sleeved cables pass through the outside body or structural members, shall have suitable gourmets/bushes made out of rubber or bakelite inserted in the holes and PVC tube carrying cable be clipped as near as possible.
- vii. Wires shall be permanently continuous color-coded and permanently number coated for easy identification of the various circuits. Use of tapped numbers is not acceptable.
- viii. Wires shall be of sufficient length to provide a loop at terminals so as to permit ample slack for directional positioning. The length shall allow replacement of end terminals twice, without pulling, stretching or replacing the wire.
- ix. Corrosion resistant full ring or interlocking terminals shall be used for terminating wire ends at components. All wires shall be continuous and terminate at appropriate connector. "T" or butt connectors shall not be used.
- x. Battery cable terminals, component terminals and connectors exposed to the ambient shall be coated with terminal corrosion preventive compound.
- xi. Except for those on large wires, such as battery cables, terminals shall be machine crimped to the wiring. A ratchet type hand crimper may be used where it is not possible to use a large machine crimper.

(k) Electrical distribution points & lighting

- i. There shall be adequate number of electric points for medical equipment
- ii. There shall be adequate number of lights, operable on 12 V DC and adequate illumination with proper lux for blood collection procedure. There shall be adequate number of lighting elements in all the three areas emitting white light meant for general lighting of the compartment as required to perform general work
- iii. Internal LED lights in all compartments with minimum 500 lux.
- iv. The lighting fixtures should be seamless in construction without any sharp edges and joineries in the frame and diffuser.
- v. The lighting fixtures should be installed in a flushed manner in the roof of the van.
- vi. All the lights should be operated on 12V DC.
- vii. 220 V AC, 5/15 Amp and Sockets.
- viii. There should be one 12V DC operated and minimum 6" wall mounted fans for each collection couch.
 - ix. Charging socket from 220 V AC with 10 metres of charging lead.
 - x. Fans 05
 - xi. Electric protection circuit for both DC & AC supply located in driver compartment for easy accessibility.
- xii. 1.9 kva invertor with chargeable system for running fans, TV, LED Lights blood bank refrigerator and music system. AC/DC Power Facility with changeover switch

xiii. All electrical fixtures should have arrangement to operate through Invertor / 230V AC supply.

(1) Fire extinguisher:

- i. The MBDV should be equipped with two standard fire extinguishers of 1 Kg capacity each.
- ii. The fire extinguisher should be secured in an extinguisher manufacturer bracket of automotive type and located in full view and in an accessible place.
- iii. The fire extinguisher should bear a label of ISI / CE / UL/ NFPA showing a rating of ABC.

3. Blood Collection Equipments:

(a) Blood Donation Couches

- i. Blood donor couch is a fix type(non-motorized) and specially designed to make blood withdrawals easier, safe and functional.
- ii. It should have fixed type. No electrically movement required. Arm rests should have swinging in and out moving facility.
- iii. Should have lifting capacity at least 350 LBS/ 150 Kgs (donor weight).
- The frame of Recliner is constructed of high grade steel duly epoxy powder coated.
- v. The base is covered with smooth and elegent finish polymer molded which is rust-free, sratch resistant and easy to clean.
- vi. It should have a top duly covered with elegant upholstered high density, max. comfort foam padding.
- vii. To have attached or detachable tray & Stand for keeping all blood collection associate accessories like- blood collection monitors tray, BP apparatus and tray for other accessories and telescopic IV stand.
- viii. Dimension: 185-190 cms (L) X 50-60 cms (W) X 80-85 cms (H), chair width both arm rest 90-92 cms

(b) Blood Bank Refrigerator

- i. Should be specifically
- ii. Should have provision for fitting to the vehicle with a minimum capacity of 100 bags (450ml) total.
- iii. The storage cabinets should continuously maintain temperature in the range of +2°C to +8°C (adjustable) with accuracy of +/-0.5°C, fitted with calibrated thermometer inside to manually check the temperature as display.
- iv. There should be an alarm system with a rechargeable battery. The alarm system should function when
 - a. When temperature goes outside the set range.
 - b. When the door remains ajar.
 - c. When there is a power failure.
- v. It should have a forced-air cooling system to allow homogenous distribution of cold
- vi. The interior of the cabinet should be suitably lighted whenever the door is opened.

- xiii. Should run on ambient temp. of 10-400C.
- xiv. Power supply: $220V \pm 10\%$, 50Hz.
- xv. The quoted model should have valid CDSCO approval.

(e) Tube Stripper

- i. Should be specifically designed for blood bank / blood centre use and not for any other purpose.
- ii. Manufacturer should be ISO 13485 certified.
- iii. Should be multi function hand stripper with metallic hand held instrument used for stripping and cutting of blood bag tube.

- 5. The firm must provide dedicated storage spaces for the following:-

 - (d) Disinfectants
 - (e) Hand sanitizer
 - (f) Gauze Pads/cotton
 - (g) Balls
 - (h) Bandages
- 6. Additional Terms and Conditions:-
