### **CLARIFICATION/CORRIGENDUM/ADDENDUM**

Subject:-Revised Technical Specifications with terms and conditions and Date extension of Bid document for Equipment Bedside Locker NIB F-8(155) RMSC/EPM/M-3/16-17/NIB-176/3593 dated: 10.8.2016.

In Reference to above sited subject and NIB-176, Revised Technical Specifications with terms and conditions and Date extension of Bid document for Equipment Bedside Locker NIB F-8(155) RMSC/EPM/M-3/16-17/NIB-176/3593 dated: 10.8.2016 as below:-

## **Revised Technical Specifications of Bedside Locker**

#### 1. Overall Dimension:

Length : 400 mm (+/- 5 mm variation) Width : 400 mm (+/- 5 mm variation) Height : 805 mm (+/- 5 mm variation)

- 2. Construction: The outside diameter of the legs of the locker should be 25 x 25 x 1.20 mm Sq. tube and 1.22 mm thick. Height of the legs from the bottom should be at least 150mm.
- 3. The cabinet body, shelf and legs should be made from CRC steel sheet in 1.0 mm thick.
- 4. The Top should be made from 1.2 mm thick Stainless steel sheet and it should have back and side bent upward for acting as a guard sheet (height of the sheet shall be 75mm).

#### 5. Cabinet: -

Dimension: Height		580mm
Width	-	400mm
Depth	-	400mm
Tolerance	1	±5mm

Cabinet having two boxes of same sizes (properly welded partition).

- 6. Door: Single door, door of the cabinet should be made from CRC Sheet of 1.25 mm thick press bent to required size. Door of the cabinet is offered with 6 ventilation louvers to provide air vents. The door should be press bend in such manner on top of door to facilitate opening/closing.
- 7. Door is pivoted to the cabinet with help of Stainless steel rod.
- 8. Pivoted Rod acting as a hinges and allow the door to swing.
- 9. Shoe made from hard rubber. Nominal height of the shoe should be 30 mm.
- **10. Finishing:** All Steel sheet components shall be made from CRCA sheet and have to be treated for the removal of free rust on the surface.
- 11. Pre-treated and epoxy powder coated should be not less than 50 micron.
- 12. Guaranty: Guaranty of one year against any manufacturing defect from the date of supply / installation.
- **13.** Manufacturer should have ISO 14001 or OHSAS 18001 or BIFMA Certifications (Valid documentation should be submitted in technical bid).

## SECTION III: QUALIFICATION AND EVALUATION CRITERIA 2.Evaluation criteria

## 5. Price and /or purchase preference:-

**5.1** The price and /or purchase preference shall be given in evaluation of bids and award of contract under Purchase of Stores (Preference to Industries of Rajasthan) Rules, 1995.

**5.2** Purchase preference to the extent of 15% of the requirement will be admissible the goods produced or manufactured by registered small scale industries of Rajasthan over goods produced or manufactured by Industries outside Rajasthan as per Purchase of Stores (Preference to Industries of Rajasthan) Rules, 1995 and approved by Board. Purchase preference admissible to the PSUs and to the SSI units of the state of Rajasthan together shall not exceed 25% (10% for PSUs and 15% of SSI units). However, these units will be required to participate in bidding and match lowest price (L-1).

**5.3** In comparing the rates quoted by firms from outside Rajasthan and those in Rajasthan but not entitled to Price Preference under GCC Clause 12 and Section-III, evaluation criteria, the element of Rajasthan VAT shall be excluded whereas that of Central Sales Tax shall be included for comparison of rates.

**5.4** While comparing the rates in respect of firms within Rajasthan the element of Rajasthan Sales Tax/VAT shall be included.

#### SECTION VI A:-GENERAL CONDITIONS RATE CONTRACT (GCC)

#### 8. Comparison of rates:

(ii) In comparing the rates quoted by a firm from outside Rajasthan and another bidder from within the state, the element of Central Sales Tax shall be added in the rates of the from outside Rajasthan and VAT or RST, if any, shall be excluded from the rates quoted. While comparing the rates in respect of firms within Rajasthan, the element of Rajasthan VAT or CST shall be excluded from the rates quote.

12. Purchase preference:

In the schedule item no. 57 is Steel Furniture. The Purchase Committee dated 5.10.16 decided that item Bed Side Locker comes under category of steel furniture. So the item Bed Side Locker is entirely reserve for Local micro and small enterprises.

SECTION VI A:-GENERAL CONDITIONS RATE CONTRACT (GCC) - Clause no. 2.6

The following documents are mandatory and shall be uploaded on e-procurement portal along with Technical Bid Submission Sheet. If the following documents/certificates/requirements are not uploaded on portal/ full filled, the bid will liable to be declared non responsive:-

- i. Cost of bid document, RISL processing fee and bid security;
- ii. In case of Indian Manufacturer, valid Manufacturing License from Competent Authority, if applicable, Acknowledgement of EM-II Memorandum/IEM/ Registration of SSI unit, copy of the registration with Central Excise Department/ exemption from registration, if applicable, as per provisions of Central Excise Act.
- iii. In case of direct Importer, Import-Export Code (IEC) Certificate and Permission/Authorisation for sale from the foreign principal manufacturer.
- iv The average gross annual turnover of the bidder shall be as per **Table-1** for last three years (**BF-VI**).
- v Declaration by the Bidder Regarding Qualifications (BF-XVI).
- vi. Bidders shall have to submit a valid 'VAT' clearance certificate from the concerned Commercial Taxes Officer or declaration and the 'PAN' issued by Income Tax Department.
- vii Duly signed scanned copy of Section VI A and VI B or BF-XIV, as acceptance of terms & conditions;

viii USFDA Certificate/CE Marking/ISO/.....etc. as/ if applicable;

## Following clarification is added:-

"Certificate should be valid on the date of Bid Submission and should remain valid till the end of Rate Contract period, if between this period certificates gets expired, then it would be bidder's responsibility to renew it and inform RMSC beforehand.

No bid will be considered if required certificate is not valid on the date of Bid submission. However, in the case where certificate has expired and manufacturer/bidder has applied for its renewal, bids will be considered only if the bidder successfully submits new certificate before determination of responsive firm for demonstration. Such case will be considered only when the bidder has informed the procuring entity regarding expiry and applied for renewal.

## In case of Mandatory Documents

Wherever certificates are being asked with respect to determining technical responsiveness of the firm/ Product, same shall be submitted at the time of bid submission only and no alternative certificate after opening of technical bid shall be entertained.

Clarification with respect to bid documents shall be considered only for those documents which are submitted by the firm at the time of bid submission".
