In reference to subject cited above and NIB-261, the representations received from the various firms and issues raised by the Bidders, are examined by the competent Authorities and Technical Committee. The following Clarification/Corrigendum/Addendum is issued for inclusion in Bid document. Revised Bid Schedule & Amended Technical Specifications of Bid document of Item "(01) Elisa Reader and Washer (02) CENTRIFUGE MACHINE - (16 TUBES) (03) CENTRIFUGE MACHINE - (36 TUBES) "as below:-

01. Technical Specifications of item ELISA READER AND WASHER.

- 1. Filter based ELISA reader with halogen lamp as light source and silicon photo detectors.
- 2. Should have a linear measurement range of 0 to 4 Abs or more
- 3. Should compatible to wavelength range from 400 to 700 nm.
- 4. Should have a photometric accuracy of  $\pm 2\%$  or better
- 5. Should have a resolution of 0.001Abs
- 6. Should have variable speed plate shaking capability
- 7. Should have easy access 8 position filkter wheel

- Both measured and calculated data can also easily be exported to other systems like Microsoft Excel for further data handling
- User should be able to load the software in to multiple computer systems for data analysis
- Software should have option for area selection i. e. different protocols at different area of the same plate
- Database based software to run backups of all data, restore backup data (in case of hardware failure of original computer)
- Supplier should quote for the following accessories: UPS, Computer with Printer
