Terms & Conditions

1. **Manufacturer should be ISO 9001 .**
2. Guarantee: **Two years** on equipment from the date of installation.
3. **Certificate of Testing should be submitted in Technical Bid , issued within last 12 months , from certified competent lab / Government Testing House /Labs.**
4. CMC: CMC will be given @5% (of net rate-inclusive of Excise Duty & exclusive of VAT/CST etc.) plus service tax (as applicable) and yearly escalation of 5% on last year's CMC price. The CMC may be awarded for three years (on yearly basis) after completion of guarantee period of two years.
5. The service engineer should be based in Rajasthan.
6. The company should mention the make and model name/number of the quoted equipment and submit the technical brochure of the quoted model in the technical compliance sheet as per technical specifications.
