Technical Specification of centrifuge tube 50 ml.

- 1. Sterile Centrifuge tubes 50 ml made of polypropylene, certificate of type of sterilization should be attached with technical bid.
- 2. Any color labeling area and printed graduation at every 5 ml or less.
- 3. Walls thick enough to allow centrifugation up to 1500g.
- 4. Solvent resistant, chemicals compatibility certificate to be documented.
- 5. DNAse/RNAse-Free.
- 6. Should withstand at 15 psi pressure & at 121° C temperature.
- 7. Manufacturer should be ISO 9001 Certified.
- 8. Certified Non-Pyrogenic (Certificate to be attached).
- 9. Individually packed with manufacturing and expiry date on label.
- 10. Flat PE screw caps should close with quick 3-4 turns.
