1. Overall approx size: 76 (L) X 46(W) X 81 (H) cm. (Tolerance  $\pm 5\%$ )
2. Frame work of MS tubes of 16G mounted on 10 cm antistatic castors.
3. Two S.S. shelves of 20G with three side railing on top shelf of suitable height.
4. Two drawer under the each shelf
5. Pre-treated and epoxy powder coated.

### **General Terms & Conditions:**

1. **Guaranty:** Guaranty of one year against any manufacturing defect from the date of supply / delivery / installation.
2. Packing shall be of good quality to avoid damage or scratches during transit.
3. Color of item shall be confirmed by ordering authority at the time of supply order or as per sample.
