Technical Specification for Patient Attendant Benches with mattress (Attendant Bed for Cottage & Cubicles) :

1. Attendant bed should be Box type with top opening with lid.
2. Frame work made of Square / Tubular pipe frame M.S. Tube 16 Gauge of 1.25”.
3. M.S. frame work mounted on PVC stumps.
4. 5 cm foam padded top on CRCA Sheet 20 Gauge thick or more, covered with thick rexine (rexine mounted on cloth), density of foam should not be less than 40.
5. Pre-treated and epoxy powder coated.
6. Overall approx. size: 180 L x 60 W x 46H cms, (tolerance $\pm 5\%$)

General Terms & Conditions:

1. **Guaranty:** Guaranty of one year on against any manufacturing defect from the date of supply / delivery / installation.
2. Packing shall be of good quality to avoid damage or scratches during transit.
3. Color of item shall be confirmed by ordering authority at the time of supply order or as per sample.
4. The final technical approval of furniture items shall be after inspection of samples by technical committee at the time of technical bid evaluation.
5. The RMSCL may do pre dispatch inspection at supplier store/ premises /factory.
