- It should be fitted with digital Timer 0-59 minutes and digital speed indicator.
 - The machine should be supplied with Angle rotor head having 36 - 40 tubes of 15ml capacity. It should be completed with S.S tube carrier, Rubber cushions, graduated plastic tubes of 15ml cap. And should also be supplied with 36-40 graduated plastic tubes of 15ml. capacity.
 - The lid should be double walled, made of steel sheet/ABS plastic injection moulding for extra safety having lid lock. It should also be fitted with electronic lid lock which should not open when machine is in running condition. It should off when machine is off after running the cycle.
 - The Motor of machine should be fitted of anti vibration pads and should brush less motor.
 - Supplied completed with instruction manual, cord and plug, dust cover, 12 spare rubber cushions, 2 spare fuse. Should be well packed in thermo cool box.
 - Machine should be ISI/CE marked.
 - **Guarantee:** Two years on equipment from the date of installation.
 - **CMC:** CMC will be given @ 5 % (of net rate - inclusive of Excise Duty & exclusive of VAT / CST etc.) plus service tax (as applicable) and yearly escalation of 5 % on last year's CMC price. The CMC may be awarded for five years (on yearly basis) after completion of Guarantee period of two years.
 - Installation will be done by supplier free of cost.
 - The service engineer should be based in Rajasthan.
 - Demonstration of equipment is must for technical approval.
 - The company should mention the make & model name of the quoted equipment and submit the technical brochure of the quoted model in the Technical bid along with compliance sheet as per amended technical specifications.


