

**Technical Specifications of Vacuum Cleaner (Wet & Dry)**

1. It should be high performance, wet & dry operation vacuum Cleaner.
  2. The maximum watt should be 2500-2800W.
  3. The water lift capacity should be 2200 mm WC  $\pm$  200 mm WC.
  4. The air flow should be 120 liters/sec  $\pm$  25 liters/sec.
  5. The effective tank capacity should be 60 liters  $\pm$  5 liters.
  6. It should operate on single phase power supply 230V- 250 V/ 50 Hz.
  7. It must have in line reusable HEPA Filter for Dry Operations and normal filter for wet function.
  8. It must be supplied with all standard accessories (minimum 08, good quality) and additional floor dry tool attachable to trolley should be supplied.
  9. Consumable: Filters excluding HEPA.
  10. It should be made of S.S., Non corrosive metal body tank with provision of bag.
- General Terms And Condition
1. Guarantee of the complete System should be of two years. CMC will be given @ 6% (of net rate exclusive of GST as applicable etc.) and yearly escalation of 5 % on last year's CMC price. The rates of CMC may be awarded for five years after guarantee of two years.
