The density of mattress foam should not be less than 40. 3. Should have a dimension of L 180 X W 90 X H 80 cm (Tolerance + 5 %). 4. Should be able to hold minimum of 150 Kg. 5. Back Rest should be adjustable on ratchet. 6. Removable SS Bowls under the U cut, size proportionate to the U cut size provided with SS head end side railing made from solid SS rod, SS hand grips. 7.
