- 6. Variable conductivity setting between 12 to 16ms/cm

- 8. Dialysate temperature regulator that has a range of temperature 35°C to 39°C
- 9. Safety device: Functioning Alarms, Venous Blood Clamp.

General Terms & Conditions:

- 1. The product should be USFDA/European CE (Notified Body) certified. (Valid documentation should be submitted in technical bid).
- 2. Demonstration of the machine is must for final technical approval.
- 3. List of consumables, accessories & spare parts as per requirement of the equipment should be provided by supplier in the technical bid.
- 4. The company have excellent service backup with resident engineer based in major cities of Rajasthan,
- 5. Installation and training for medical/technical staff to getting acquaint with machine at consignee will be done by the supplier free of cost. Operating manual/training material (1set) will be supplied by the supplier free of cost at the time of installation.
- 6. 3 year warrantee on complete product from the date of installation.
- 7. CMC: CMC will be given @ 5% exclusive GST (as applicable) and yearly escalation of 5% on last year's CMC price. The CMC may be awarded for five years (on yearly basis) after completion of warrantee period of three years.
- 8. Four Preventive Maintenance services during warrantee and CMC period are essential. The company should submit technical compliance sheet as per technical specifications mentioning the make & model of quoted product along with catalogue in the Technical bid.

Technical specifications of RO Water System (250 litre/Hour) for Heamodialysis Machine

- 1. It should have capacity to produce 250 Liter Hour post RO water.
- 2. It should have Raw water tank, multi grade Filter, Iron removal, Charcoal (twin) Filter, softener, Reverse Osmosis, Ultra Violet Sterilizer, RO water storage tank of 1000 liters.
- 3. It should have Rinse and Flush facility for the membranes in R.O. Unit.
- 4. It should have conductivity meter, Pressure Gauge, Flow indicator.
- 5. The chemical, contaminants, endotoxin and microbial tests of post R.D water should pass AAMI standards.
- 6. Technical evaluation of Water Treatment Plant RO System shall be done with technical documents, if the bidder has an installed RO System at any Government institution than bidder has required to submit its satisfactory installation report. Otherwise, The bidder shall make arrangements for physical inspection, where the RO system of the bidder is installed.



The bidder, who gets the purchase order for installation of RO System, will install RO System at one consignee institute and only after getting the report of satisfactory installation and performance from that consignee Institution, will install RO system in the rest of the consignee Institutes.

- 7. Guarantee for Water Treatment Plant R.O. System shall be taken for two years and CMC for Five years.
- 8. Firm shall provide a 1000 Liters Water Storage Tank with each Water Treatment Plant (WTP) R.O. System
- 9. Firm shall install the pipeline from Raw Water Storage Tank or Hospital Campus Water Source to Water Treatment Plant (WTP) R.O. System (with commissioning)
- 10. All work related to installation of R.O. system and connection of R.O. water to Dialysis Machine and drainage will be completed by the bidder.
