

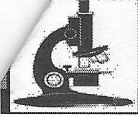

The instrument trolley's tabular frame should be made up of Stainless steel with 20mm\pm 2mm. dia. The trolley should be with two heavy duty stainless steel shelves with dimensions 750mm (l) x 500mm (w)\pm5mm. Both S.S. shelves with protective stainless steel railings on all four sides on the top. Trolley should have 125mm diameter 4 castors with synthetic body, two with brake and two without brake.
