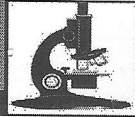

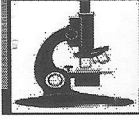

Adjustable back rest by hand lever. 4. 2 section cushioned top. 5 cms foam cushioned top covered with rexine. 5. Legs should be fitted with strong PVC stumps. 6.
