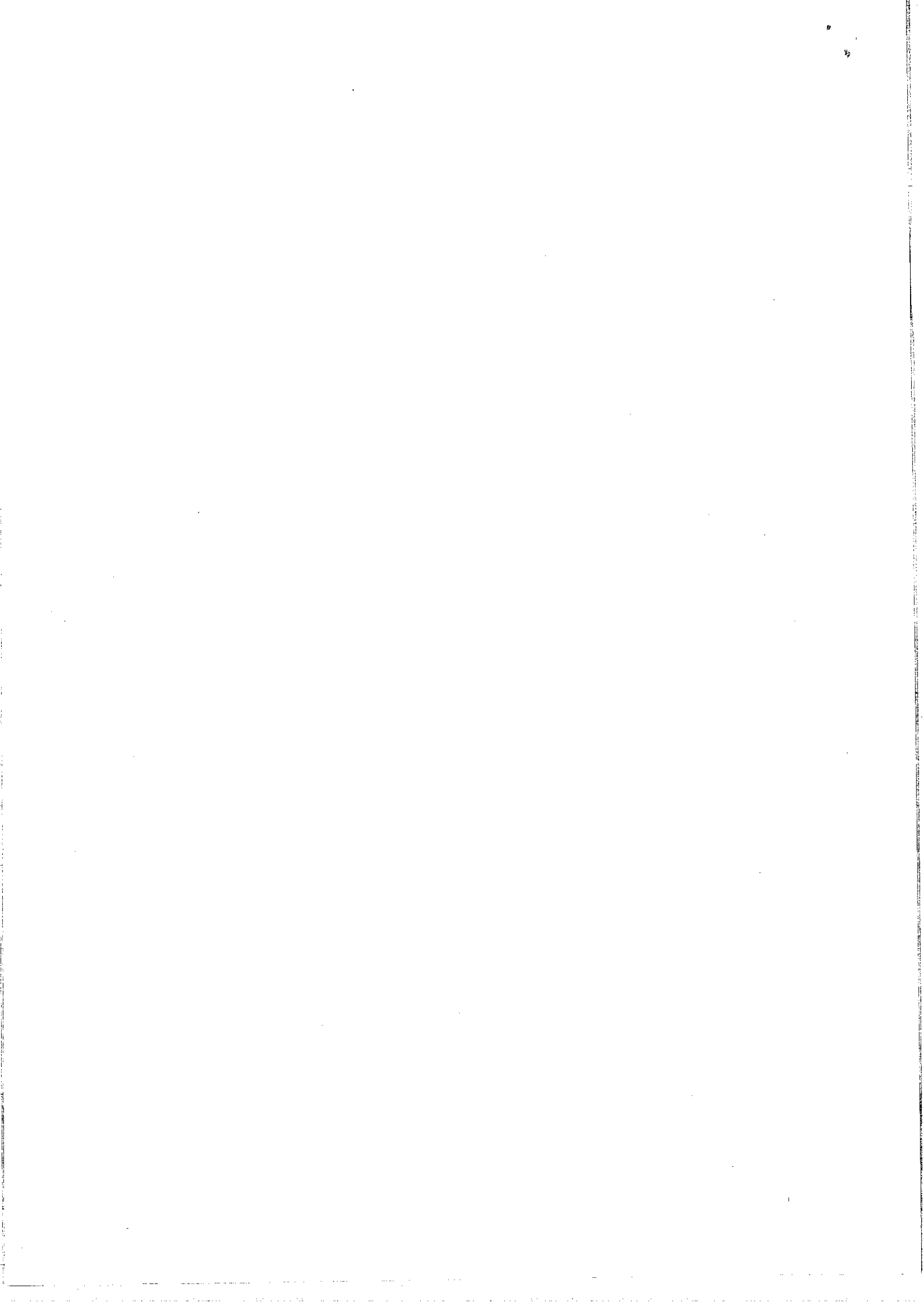

8. Sensitivity settings: should have trigger and cycle setting.
9. Unit should have integrated alarm for power, Pressure (High/Low), Low Minute ventilation, Apnea, Respiratory rate (High/Low), Circuit disconnected etc. With digital technology for improved leak compensation during inspiration & exhalation.
10. Complete unit should be supplied in good quality bag which can carry both adult and paediatric circuit and mask along with equipment.
11. Unit should be European CE or FDA approved. (Valid certificate should be submitted in technical bid).
12. Unit should have battery backup capacity of 2 hour or more.
13. Unit should be supplied with reusable patient circuit and reusable full face mask with harness Adult & Paediatric (1 no. each), operational / training manual (1 no.).
14. **Guarantee:** Three years from the date of installation.
15. **CMC:** CMC shall be given @ 5% of net rate (excluding GST as applicable) and yearly escalation of 5 % on last year's CMC price. The CMC may be awarded for five years (on yearly basis) after Guarantee period of three years.
16. Installation will be done by supplier free of cost.
17. Firm should have service engineer network in Rajasthan.
