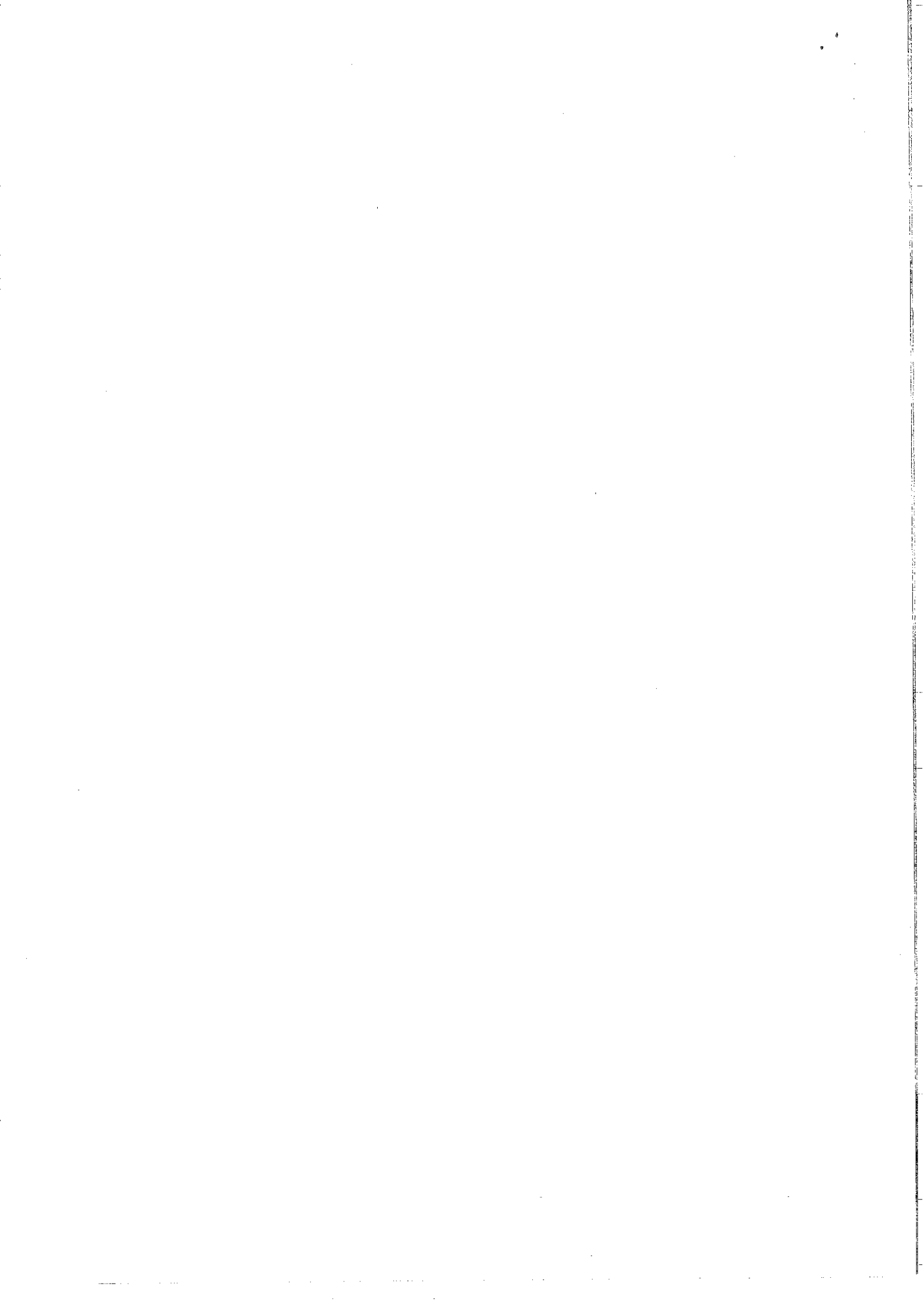

- The overall dimension of instrument trolley: 750mm (l) x 500mm (w) x 900mm (h) ±5mm.
- The instrument trolley's tabular frame should be made up of Stainless steel with 20mm±2mm. dia.

4. The trolley should be with two heavy duty stainless steel shelves with dimension 750mm (l) x 500mm (w)  $\pm$ 5mm.
5. Both S.S. shelves with protective stainless steel railings on all four sides on the top.
6. Trolley should have 125mm diameter 4 castors with synthetic body, two with brake and two without brake.

**Other terms and conditions:**

1. Manufacturer should be ISO- 9001 certified.
2. **Guarantee:** should be one year for all items from the date of successfully installation at consignees address.
