## CLARIFICATION/CORRIGENDUM/ADDENDUM

Subject: -Revised technical Specifications and other terms and conditions of Bid document THE RATE CONTRACT FOR Section-J Hospital Furniture and other Supplies For Year 2014-15 under NIB No. F-8()RMSC/EPM/M-2/14-15/NIB-60/7252 Dated: 23.12.2014

In Reference to subject cited above and NIB-60, the various representations received from the firms and issues raised by the Bidders are examined by the competent Authorities and technical committee. The following Corrigendum/Addendum is issued for inclusion in bid document & Technical Specification of items (Section-V, Schedule of Supply, Point no. 3) as below:-

## 1. Clarifications regarding specifications of Hospital Furniture and other supplies

## (i) Item Bedside Locker:

The top should have back and sides bent upward for acting as a guard railing (not less than 3 inches) and the front side should be bent downward at 180 degree to avoid any injury.

## (ii) Item Foam Mattress:

Should be made from latex foam rubber & density should not be less than 40. Mattress should not break by pinching or pressure & should not get compressed in less than 2 years.

- Note: (a). Guarantee on all the items shall be one year after installation / delivery, against any manufacturing defects.
- (b). Certifications: Should have ISI or any quality assurance certificates like CE / ISO / OHSAS 18001 / BIFMA, etc. will be considered but specifications should not be less than the specifications defined/mentioned in concerned IS certification for all the items.
- 2. Section IV technical bid submission sheet (Cover-A) point no. 12 (v) is deleted and added at Section III.
- 3. Section III, evaluation and qualification criteria, point no. 2, clause no.8 Tax clearance certificates:-The VAT/Sales Tax and other taxes clearance or declaration is to be submitted by the bidder. Bidders shall have to submit a valid 'VAT' clearance certificate from the concerned Commercial Taxes Officer or Affidavit and the 'PAN' issued by Income Tax Department.
- 4. Section II Bid Data Sheet (BDS) point no. 6.3 is read as "The Performance security shall be required as per GCC-10 (iii) @ 5% of the value of the indicative quantity in the bid subject to a maximum Rs. 10.00 lacs for each item in favor of MD, Rajasthan Medical Services Corporation Ltd., Jaipur."
- 5. It is clarified that Information of award of contract shall be communicated to all participating bidders on the website www.rmsc.nic.in and sppp.raj.nic.in. Please note that individual bidder will not be intimated.
- 6. It is also further clarified that, if any amendment/clarification is carried out in the technical specifications and bid terms & conditions following pre-bid meeting or any other information, the same will also be uploaded on the Corporation website <a href="https://eproc.rajasthan.gov.in">www.rmsc.nic.in</a>, sppp.raj.nic.in and <a href="https://eproc.rajasthan.gov.in">https://eproc.rajasthan.gov.in</a> and will not be published in news papers.
