- 3. Representation against responsiveness of item code S-9(a) to S-9(g) of M/s Sutures India Pvt. Ltd., is given by M/s MRK Healthcare Pvt. Ltd. After reevaluation the Product Permission of M/s Sutures India Pvt. Ltd. for S-9(a) to S-9(g) is not found correct (length is not as per tender). Moreover in check list, the firm has mentioned BSEN Standards which is not as per tender specification. Considering all the facts, the decision of non responsiveness of item code S-9(a) to S-9(g) of the firm M/s Sutures India Pvt. Ltd. is taken by Purchase committee.
- 4. Representation against non responsiveness of the firm is given by M/s Suru International Pvt. Ltd. It was re-examined and responsiveness of the quoted items was decided accordingly.
