Average Annual turnover (for Drugs & Medicines including Surgical and sutures Business) in the last three financial years (2009-10 and 2010-11, 2011-12) shall not be less than **Rs. 5 Crores for sutures and 2 crores for other items.** The same should be supported by audited annual accounts & certified by a Chartered Accountant. Provisional / Audited (by CA) Turnover, P&L, Balance sheet of financial year 2012-13 may be accepted but the firm has to submit audited final accounts before execution of agreement. If the firm fails to produce audited final accounts, it will be liable for action as applicable in the case of non execution of agreement.

3. Clause 5(h) on Page 5 is replaced by:

Bidder should have at least 3 years market standing as a manufacturer for the items quoted in the tender (3 years should have been completed from the

date of commencement of manufacture of the first batch of the item, on the date of bid opening). The bidder should have manufactured and sold at least 5 commercial batches of the quoted item in a year for the last 3 financial years; the bidder shall furnish the information of all batches manufactured year wise in the format given in Annexure- XI (Performance Statement) (Enclosed). Documents in proof of such manufacture / sale shall be submitted. Samples of the items which are supposed to be sterile, should be sterile. The decision based on quality evaluation of the sample will be final for the purpose of this tender.
