NOTIFICATION

G.S.R.:- In exercise of the powers conferred by section 54 of the Air(Prevention and Control of Pollution)Act,1981(Central Act No. 14 of 1981), the State Government after consultation with the Rajasthan State Pollution Control Board, hereby makes the following rules further to amend the Rajasthan Air(Prevention and Control of Pollution) Rules,1983, namely:-

1. Short title and commencement - (1) These rules may be called the Rajasthan Air (Prevention and Control of Pollution) (Amendment) Rules,2007.
(2) They shall come into force on the date of their publication in the Official Gazette.
2. Amendment of rule 5 - In rule 5 of the Rajasthan Air (Prevention and Control of Pollution) Rules 1983, hereinafter referred to as the said rules, the existing sub rule (1) shall be substituted by the following, namely:-

“(1) Application under rule 4 shall be accompanied by the fee as mentioned in the Schedule appended to these rules:

Provided that where a person who is establishing or operating any industrial plant and is generating hazardous waste as defined under the Hazardous Wastes(Management and Handling) Rules,1989 and requiring authorization thereunder; the application for consent shall be accompanied with a fee equal to one and half times of the amount of fee prescribed under the Schedule.

3. Amendment of Schedule - The existing Schedule appended to the said rules shall be substituted by the following, namely:-
