Minutes of the Meeting

4.6th Meeting of the State Level Environment Impact Assessment Authority, was held on **19.02.2019 at 11.00 AM** in the Chamber of Chairman, SEIAA, at Aravali Bhawan, Jhalna Doongri, Jaipur under the Chairmanship of Shri R.K Meena, Chairman, SEIAA to discuss and decide upon the following agenda :-

1	Agenda No. 1. Disposal of EC cases of Minor minerals having lease area from 0 to 5ha in the present scenario (Proposal of the State Government)
2	Agenda No. 2. Guidelines for obtaining EC for Stone Crusher Units/M-sand manufacturing units on the mining lease area.

Following decisions were taken:

Agenda no. 1 The Authority decided that since the matter is sub-judice and MoEF has already filed an SLP in the Hon'ble Supreme Court, it would be proper to wait for the directions of the Hon'ble Court in this matter.

Agenda no. 2 After detailed discussion, the Authority decided to issue Guidelines for obtaining EC for Stone Crusher Units/M-sand manufacturing units on the mining lease area as follows:

Guidelines for obtaining EC for Stone crushing units/ M-Sand manufacturing units on the mining lease area

All the mining projects having a valid EC for mining and who propose to carryout stone crushing /M-Sand manufacturing activity on the existing mining lease to meet out requirement of Gitti, Bajari (river sand) and to gainfully utilize over burden (OB) for manufacturing Gitti, Bazari / M-sand etc. are required to get the EC amended from the competent authorities as per EIA notification dated 14.9.2006 and amendments made from time to time.

The procedure and steps to get the EC amended as per the EIA Notifications are :

The list of main documents required are as follows:-


- a. Form 1
- b. Modified Mining Plan or location of Crushing / M-Sand manufacturing activity.
- c. Prefeasibility Report
- d. Compliance report of existing EC
- e. Affidavit stating that the Project Proponent (PP) has made compliance of each condition of EC/CTE/CTO and has not made violation of the provisions of EP Act, 1986, Air Act, 1981, Water Act, 1974 and has not made breach of the directions dated 2.8.2017 of the Hon'ble Supreme Court in the matter of Writ Petition (Civil) No. 114/2014, Common Cause V/s Union of India.

Steps :-

- a) The application along with all the documents is to be made online on the MoEF & CC website www.environmentclearance.nic.in. to SEIAA, Raj. for mine lease up to 100 ha. For area more than 100 ha. at EAC, New Delhi.
- b) On submission of documents in hard copy at SEIAA, the SEIAA will forward to SEAC, Raj.
- c) The PP has to make a presentation for appraisal at SEAC, Raj. as per procedure prescribed in the EIA, notification and submit additional information/documents, if any, asked by the SEAC.
- d) Based upon the recommendation of SEAC, the SEIAA will issue amendment in the EC.

The meeting ended with a vote of thanks to the Chairperson.
