

1. The Committee will prepare time bound Action Plans for 4 clusters identified by the NGT in order dated 13.12.2018 within time frame stipulated by the Hon'ble NGT.
2. The Committee will monitor the implementation of orders of NGT issued in the original application no. 1038/ 2018 in future.
3. Looking to the fact that increasing number of directions/ orders are being issued by Hon'ble NGT for Environment this committee will also be the monitoring/ implementing committee for other orders issued by the Hon'ble NGT from time to time..
