Office Order

All the Health Care Facilities were exempted from depositing back fee (gap period fee for operation without authorization/ consent) while seeking authorization under Bio-medical Waste Rules and consent to operate under the Water (Prevention and Control of Pollution) Act, 1974 and/ or Air (Prevention and Control of Pollution) Act, 1981 vide office order no. F-16(Gen-43)RPCB/BMW/463-502 dated 01.11.2019. However, this exemption was applicable for the authorization/ consent applications received up to 31.03.2020. Exemption from depositing back fee by the Health Care Facilities was extended for the authorization/ consent applications received on or before 31.12.2020 vide office order no. F.16(Gen-43)RPCB/BMW/609-648 dated 27.08.2020. The exemption was further extended for the authorization/consent applications received on or before 30.06.2021 vide office order no. F-16(Gen-43)RPCB/BMW/1469-1510 dated 01.01.2021

The matter was reviewed. It has been observed that a large number of government and private Health Care Facilities have still not obtained authorization under Bio-medical Waste Rules and consent to operate under the Water (Prevention and Control of Pollution) Act, 1974 and/ or Air (Prevention and Control of Pollution) Act, 1981.

In view of above and looking to the current pandemic conditions it has been decided that exemption from depositing back fee by the Health Care Facilities considered vide above referred office orders dated 01.11.2019, 27.08.2020 and 01.01.2021 shall continue to be applicable for the authorization/ consent applications received on or before 31.12.2021.

This bears approval of the competent authority.
