## Order

In partial modification of Board's orders no. F.12(5-Adm)/RSPCB/1665-1671 dated 24.08.2023, the power to grant, refuse and revoke Consent to Establish/Consent to Operate under the provisions of the Water (Prevention & Control of Pollution) Act, 1974 and/or Air (Prevention & Control of Pollution) Act, 1981 and Authorization under the Hazardous and Other Wastes (Management & Transboundary Movement) Rules, 2016 is hereby delegated to the Regional Officers of the State Board for following Orange and Red Category Industries/Projects/Processes/Activity located within their territorial jurisdiction:-

- A. In orange category, cases of Building & Construction projects up to 50,000 Sq. Meter built-up area shall be dealt by the Regional Officers.
- B. The cases of following industries/projects/processes/activities under Red Category shall be dealt by the Regional Officers:-

1.	Yarn/textile processing involving any effluent/emission generating process bleaching, dyeing, printing and scouring having discharge upto 200 KLD.
2.	Tanneries connected with CETP.
3.	Dyes and Dye-Intermediates (Micro, Small and Medium Enterprises)
4.	Ink, Pigment and Intermediates other than formulation (Micro, Small and Medium Enterprises)
5.	Manufacturing of Paints, Varnishes, Pigments and Intermediate (excluding blending/ mixing) (Micro, Small and Medium Enterprises)
6.	Organic chemicals manufacturing(excluding formulation) (Micro, Small and Medium Enterprises)
7.	Synthetic detergents and soaps (Large and Medium scale)
8.	Chlor Alkali (Micro, Small and Medium Enterprises)

### Note:

- 1) The criteria for classification of Micro, Small and Medium Enterprise (MSME) shall be in accordance with Ministry of Micro, Small and Medium Enterprises, Government of India and mentioned in Board's order no. F.12(5-Adm)/RSPCB/1665-1671 dated 24.08.2023.
  - 2) The condition no. D(2) mentioned in Board's order no. F.12(5-Adm)/RSPCB/1665-1671 dated 24.08.2023 is deleted.
  - 3) Regional Officers are authorized to grant, refuse and revoke Consent to Establish/ Consent to Operate/Authorization of EC requiring sectors, wherein powers delegated by the State Board to the Regional Officers.
- This bears the approval of Competent Authority.
