## Office Order

With an aim to increase forest cover in the state outside forest area, Forest Department, Government of Rajasthan has launched its flagship scheme. Tree outside Forest Area in Rajasthan (TOFiR) with a target of plantation of 5 crores plants outside forest area in the State involving various organizations, departments and citizens in the year 2023-24.

In order to promote the scheme, Finance Department, Government of Rajasthan, vide ID no. 102301716 dated 14.07.2023, has accorded financial approval giving 50% discount on purchase of 50,000 to 2 lac plants and 75% discount on purchase of plants more than 2 lacs by any organization under this scheme.

To promote the scheme and to create mass sensitization on plantation for environmental protection, it has been decided that all Regional Offices of the State Board shall coordinate with various industrial associations/ NGOs/ organizations under their jurisdiction and take benefit of the recent incentive in the scheme and carry out mass plantation in areas outside forest area in their respective jurisdiction.

In this regard, ***all Regional Officers, Regional Offices, RSPCB are directed to get at least 50,000 plants ordered through Industrial Associations in their jurisdiction by 31.07.2023.***

In case of further assistance in the scheme, Regional Officers are directed to contact respective District Conservator of Forests, Forest Department, Government of Rajasthan.
