## Office Order

All stone crushers located on mining leases were supposed to get EC amended and submit to the State Board as per the Board's Office Order dated 14.02.2019 (with erstwhile office order dated 24.01.2017).

The MoEF & CC vide it's letter dated 05.11.2019 has given a clarification that **"no separate environmental clearance or amendment in EC is required for setting up activities which does not attract the provisions of EIA Notification, 2006, in the premises of project/activities which are operating with prior EC, However, such activities shall be required to obtain consent under Air and Water Act, if applicable."**

In view of above, the State Board has issued an office order vide letter no: F14/(56-B)/Policy/RSPCB/Plg/1063-99 dated 13/11/2019 stating that henceforth, Environmental clearance or amendment in EC for setting up of activities which do not attract the provisions of EIA Notification,2006,in the premises of project/activities which are operating with prior EC shall not be sought. However, such activities shall require to obtain consent under Air and Water Act.

In light of the above, the office order no. SCMG & D.S. (Gen-03)/RPCB/1093 dated 14/02/2019 has become infructuous and therefore stands withdrawn.

All cases of stone crusher, mineral grinding and other mineral processing units (screening and washing) etc. shall be dealt in accordance with the State Board office order 13/11/2019, henceforth.


