1. Organize special camps at HO/ RO on Friday of every week to expedite disposal of pending consent applications.
2. Regional Officers may consider holding camps at location where large number of such cases are pending.
3. Concerning GIC/ROs to ensure widespread publicity of the camps and invite project proponents to come with deficient documents/ details on account of which applications are held pending for.
4. Concerning GICs/ ROs to ensure disposal of applications where documents have been submitted in one camp by the date of next camp.
