

Office Order

The State Board vide its office order no. F. 14 (23) Policy/RSPCB/Plg/779 dated 15.07.2020 had delegated various powers to Regional Offices w.r.t grant or refusal of consent and authorization applications. Vide the referred order it had been decided that in case of refusal of any application at the Regional Office level, the decision on the application submitted subsequently by the unit shall be taken at RSPCB, Head Quarter level only. It has been observed that despite this, there are different practices being followed at Head Office for processing and disposal of such applications.

In order to streamline the process, the matter has been reviewed, and it has been decided that, henceforth, **"in all cases of subsequent applications after refusal of Consent /Authorization at RO level, the Regional Officer shall get the application complete in all respect including rectification of the grounds of refusal, and then forward the original file to the concerning GIC. The GIC shall process the file in the same manner as the files in the Group are processed. After completing processing and obtaining approval for disposal (grant or refusal) of the application, the file shall be returned by the GIC to the RO for issuing letter."**

All Group In-charges/ Regional Officers must ensure compliance of the above directions.
