Office Order

The State Board, vide Office Order dated 17.02.2026, assigned plantation targets to all Regional Offices for undertaking plantation activities during the year 2026-27 under the Hariyalo Rajasthan programme.

Representations have been received from the Regional Offices, Jodhpur (U), Balotra and Pali, requesting reconsideration of their assigned plantation targets. The Regional Offices have submitted that the major industrial sector within their respective jurisdictions comprises textile industries and that, in coordination with these industrial stakeholders, they have been undertaking mass plantation activities to achieve the assigned targets. However, these textile industries are presently closed in compliance with the directions of the Hon'ble Supreme Court. As a result, the Regional Offices have expressed their inability to achieve the existing plantation targets and have requested for a suitable revision thereof.

The matter has been examined by the State Board. Considering the prevailing circumstances and the practical difficulties faced by the above Regional Offices, it has been decided to revise their plantation targets to facilitate effective implementation of the Hariyalo Rajasthan programme.

Accordingly, in partial modification of the Office Order dated 17.02.2026, the revised plantation targets for the Regional Offices of Jodhpur (U), Balotra and Pali for the year 2026-27 shall be as follows: -

Regional Office	Earlier Plantation Targets	New Plantation Targets
Jodhpur (U)	1,50,000	75,000
Balotra	2,50,000	1,75,000
Pali	2,00,000.	75,000
