Office Order

In continuation to this office earlier orders dated 01/02/2018 and 05/02/2018 w.r.t. compliance to the notification no. G.S.R. 45 (E) dated January-19, 2018 issued by Ministry of Environment, Forest and Climate Change, Government of India, New Delhi regarding use of pet coke in lime kiln units of the State, the 06 more lime kiln units name of which is mentioned in the list annexed to this order are hereby permitted to use pet coke as a fuel in accordance to the quantity mentioned against their name in column no 7 & 8 of annexed list with following conditions:-

- i. That the unit shall not store pet coke for more than its three months consumption.
- ii. That the unit shall procure pet coke from registered producer or refineries and their registered / authorized dealers only.
- iii. That the trading of pet coke by the unit is not permitted.
- iv. That the unit shall submit details of pet coke purchased from various sources during the month (imported, purchased from refineries or authorized dealers), quantity consumed during the month and opening and closing stock to the State Board on quarterly basis.
- v. That the unit shall comply with all other directions as contained in said notification dated 19.01.2018 issued by MOEF&CC, New Delhi.
