

General Terms and conditions for Bid for special Ambient Air Quality Monitoring on the occasion of Deepawali Festival-2019

1. Air quality monitoring shall be carried out for consecutive 15 days commencing from 20th October, 2019 to 3rd November, 2019 for PM₁₀, PM_{2.5}, SO₂, NO₂ and metals (Pb, Ni and As in PM₁₀) selected metals/elements (Pb, Ni, As, Al, Ba, Fe, Sr, in PM_{2.5}) to assess to impact of firecracker bursting during Deepawali festival.
2. For analysis of regulatory parameters like PM₁₀, PM_{2.5}, SO₂, NO₂ and metals (Pb, Ni and As in PM₁₀) CPCB guidelines volume-I may be adopted for metal/elements analysis in PM_{2.5} (PTFE filter) EDXRF is the best option however other suitable method (ICP-MS/ICP-AES) may also be adopted.
3. Bid must be enclosed in a properly sealed envelope.
4. The bidder shall sign the Bid form at each page and at the end in token of acceptance of all the terms and conditions of the bid.
5. Rate shall be written both in words and figures. There should not be errors and/or over writings, corrections if any, should be made clearly and initialed with dates. The rate should mention element of the all the Taxes.
6. All rates quoted must include all types of charges.
