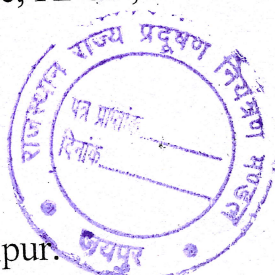
Rajasthan State Pollution Control Board, Alwar invites limited Bid method tender from the MoEF and CC recognized laboratory having adequate monitoring and analysis facilities and have sophisticated instruments like- ICP-MS, PM_{2.5} Sampler, UV- Visible spectrophotometer etc. for Special Air quality monitoring at 02 locations (on 24 hours basis) for consecutive 15 days commencing from **13th October, 2025 (6.00 AM) to 27th October, 2025 (6.00 AM of 28/10/2025)** as per protocol for PM₁₀, PM_{2.5}, SO₂, NO₂ and metals (Pb, Ni and As in PM₁₀) and additional selected metals/elements (Al, Ba, Fe in PM_{2.5}) to assess the impact of firecrackers bursting during Deepawali festival at Alwar at 02 locations. For analysis of regulatory parameters like PM₁₀, PM_{2.5}, SO₂, NO₂ and metals (Pb, Ni, and As in PM₁₀) CPCB guidelines volume-1 may be adopted. For metal/elements analysis in PM_{2.5} (Al, Ba & Fe) (PTFE filter), EDXRF/ICP-MS/ICP-AES) may be used.

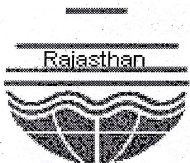

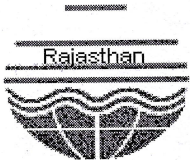

General Terms and conditions of Bid (Request for Quotations Method) for Special Ambient Air Quality Monitoring & Analysis work on the occasion of Deepawali festival -2025

1. Air quality monitoring shall be carried out at 02 locations (on 24 hours basis) for consecutive 15 days commencing from **13th October, 2025 to 27th October, 2025**, as per protocol for PM₁₀, PM_{2.5}, SO₂, NO₂ and metals (Pb, Ni and As in PM₁₀) selected metals/elements (Al, Ba & Fe, in PM₂₅) to assess the impact of firecracker bursting during Deepawali festival 2025.
2. For Monitoring and analysis of regulatory parameters like PM₁₀, PM_{2.5}, SO₂, NO₂ and metals (Pb, Ni, and As in PM₁₀) CPCB guidelines (volume-1) may be adopted. For metal/elements analysis in PM₂₃ (Al, Ba & Fe in PM_{2.5}) (PTFE filter), EDXRF is the best option however other suitable method (ICP-MS/ICP-AES) may also be adopted.
3. **The Bidder shall submit the proof of (ICP-MS/ICP-AES) or EDXRF with copy of these instrument purchased by the firm and all above parameters are in their valid SCOPE, as per NABL/MOEF&CC with present NABL calibration certificate that instrument as a mandatory document.**
4. Bids must be enclosed in a properly sealed envelope.
5. The Bidder shall sign the Bid form at each page and at the end in token of acceptance of all the terms and conditions of the Bid.
6. Rate shall be written both in words and figures. There should not be errors and/or over-writings, corrections if any, should be made clearly and initialed with dates. The rates should mention inclusive of the all the Tax.
7. All rates quoted must include all types of charges and Taxes.
8. **Inspection:** The Board Officers or his duly authorized representative shall at all reasonable time have access to the laboratory premises and shall have the power at all reasonable time to inspect and examine the samples and procedure of monitoring.
9. **05% of performance security of Rs.9950/-** (In words-Nine Thousand Nine Hundred Fifty) of the bid price in favour of Regional Officer, RSPCB, Alwar, payable at Alwar will be submit with bid form and will be returned after the submission of the all the reports related to this monitoring and prior approval or recommendation of concerned section.

13. If any dispute arises the matter shall be referred to the Regional Officer, RSPCB and his/her decision shall be final.
14. Regional Officer, Alwar has rights to reject/cancel the tender at any stage without any further clarification.
