CLARIFICATION/CORRIGENDUM/ADDENDUM

Subject: -Revised Technical Specifications and other terms and conditions, Revised BOQ & Date Extension of Bid document for HOSPITAL FURNITURE AND OTHER SUPPLIES NIB F-8 (212) RMSC/EPM/M-3/16-17/NIB-216/458 dated: 3.2.2017.

In Reference to subject cited above and NIB-216, the various representations received from the firms and issues raised by the Bidders are examined by the competent Authorities and technical committee. The following Corrigendum/Addendum is issued for inclusion in bid document & Technical Specification of items (Section-V, Schedule of Supply, Point no. 3) as below:-

1. Revised Technical Specifications of items:-

1. Technical specification of Stead Bed

- Fixed height
- Overall Size approximate 1900mm x 920mm x 600mm for use of mattress size 72" x 36" x 4".
- Rigid perforated sheet platform.
- Legs should be fitted with strong PVC stumps.
- The bed platform should be made from minimum 18 G thickness CRCA Sheet bent downwards for strong study.
- Pre-treated epoxy powder coated.
- Provision to hold IV Rod at four locations should be supplied with one SS Telescopic IV Rod with four hooks.
- Provision for mosquito net poles on all sides.
- Should have bearing capacity of 250 kg.
- Final technical approval after demonstration.
- Guarantee on the item shall be One year after installation/delivery against any manufacturing defect.
- Company should have ISO 9001, 13485 certification.

2. Technical specification of Examination Table

- Approximate dimension: 72" L x 24" W x 32" H tolerance ± 2 cms.
- The table platform should be made from minimum 18 G thickness CRCA Sheet bent downwards for strong study.
- Adjustable back rest by hand lever.
- 2 section cushioned top. 5 cms foam cushioned top covered with rexine.
- Legs should be fitted with strong PVC stumps.
- Finish: All components will be thoroughly pre-treated chemically to remove rust and foreign matter like grease, oil, etc by epoxy powder with minimum 50 micron thickness paint film.
- Final technical approval after demonstration.
- Guarantee on the item shall be One year after installation/delivery against any manufacturing defect.
- Company should have ISO 9001, 13485 certification.

3. Technical specification of Kidney Tray

- Kidney Tray of stainless steel grade 304 G of thickness 0.5 mm.
- Size: 6", 8", 10" & 12" (in inches)

- Kidney tray should be free from sharp or open edges, distortion, dents, wrinkles, wavy surface, burrs, scratches & pitting.
- Test report of stainless steel should be attached.
- Final technical approval after demonstration.
- Guarantee on the item shall be One year after installation/delivery against any manufacturing defect.
- Company should have ISO 9001, 13485 certification.

4. **Technical specification of Instrument Tray (with lid, made thick gauge S.S sheet)**

- Instrument Tray of stainless steel grade 304 G of thickness 0.5 mm.
- Size: 9" x 6", 10" x 8", 11" x 7", 12" x 8" & 12" x 10". (in inches)
- Instrument tray should be free from sharp or open edges, distortion, dents, wrinkles, wavy surface, burrs, scratches & pitting.
- Test report of stainless steel should be attached.
- Final technical approval after demonstration.
- Guarantee on the item shall be One year after installation/delivery against any manufacturing defect.
- Company should have ISO 9001, 13485 certification.

3. Wherever the word Direct Importer mentioned in the Bid document is deleted except for the item Foam Mattress size 72"X36"X4" with rexin cover both ISI Marked IS No. 1741-1960 and amended up to date.


