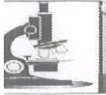

11	<p>1 .Technical Specifications of Sleeves Lupin 4FDC</p> <p>The below specifications are specifications for technical content and for physical design for printing the 99DOTS envelopes which wrap around Fixed Drug Combination (FDC) medications. These specifications are for the universal envelop (not weight band dependent). The 4FDC and 3FDC envelopes are different sizes, as per the attached dye designs. Each envelope is printed with a different sequence of numbers, which is unpredictable to patients before dispensing but known to the 99DOTS algorithm.</p> <p>I. Technical Contents Specifications of Upchaar Suchana Envelope</p> <ul style="list-style-type: none"> • Prototype Technical content for printing on Envelop is given in the below table. <p>II. Physical Design Specification for Envelop</p> <ul style="list-style-type: none"> • Prototype Design is given in annexure 1 to illustrate the design and for dimensions.

1.	Envelop Size	<ul style="list-style-type: none"> The final size of Envelop will be 12.3 cm x 20.4 cm (length x width) For Size of Envelop dyes, flaps, perforations, pill compartments, please see Annexure I. (Annexure I (Part 1 to 4) is attached at the end of bid document)
2.	Envelop dyes [See attached]	<ul style="list-style-type: none"> The dimensions are mentioned in the figures. The envelope is initially a single large sheet. One side folds over. Two sides have flaps which are folded over and sealed with glue at the manufacturer level The remaining side is open and is fixed with a double-sided tape- There is also an opening to see the expiry date (dimensions in figures)
3.	Envelop skews	<ul style="list-style-type: none"> There will be 50 skews (each) for both 4FDC and 3FDC drugs. All 50 will have different number sequences Since there are 50 variants of each envelope, each Skew can be printed Separately and then the 50 Skews shuffled
4.	Printer type	An offset lithographic printer
5.	Double sided tape for envelop sealing	8mm A-grade solvent-based double-sided tape
6.	Paper grade	210 GSM CFBB
7.	Pill Compartments	<ul style="list-style-type: none"> One side of the envelope has openings for the elevated pill holders present in the blister and the other side has flaps with perforations to allow pills to be dispensed (dimensions in figures). There are 28 such pill compartments - same as the number of pills in 4FDCs and 3FDCs The flaps are pre-cut along the two long edges, folded at one of the short edges, and perforated along the last short edge. On the inner side of the flaps, phone numbers are printed on 14 of the 28 flaps (2nd and 4th flap in 1st column, 1st and 3rd flap in 2nd column; 2nd and 4th flap in 3rd column, 1st and 3rd flap in 4th column, 2nd and 4th flap in 5th column, 1st and 3rd flap in 6th column, 2nd and 4th flap in 7th column), The outer sides of the flaps which have the phone numbers on the inside have a "phone call" symbol on the outside. The dimensions of these mentioned in the figures.
